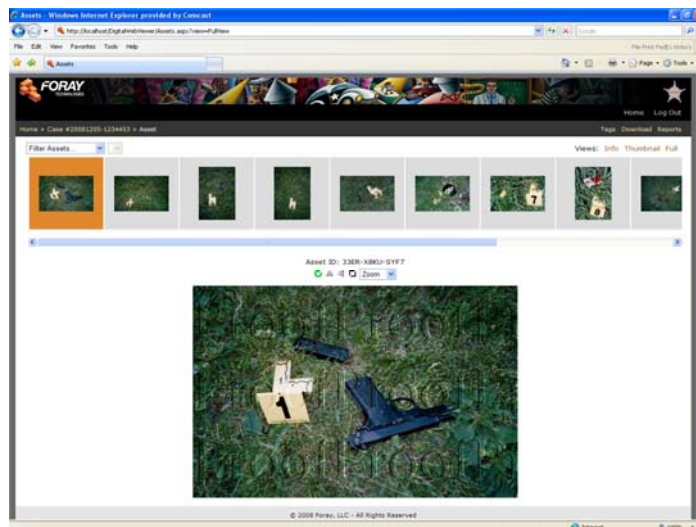

DIGITAL IMAGING TRAINING GOES ABROAD

Teaching forensic imaging techniques in Switzerland & Croatia:

David "Ski" Witzke was a keynote speaker and conducted hands-on, advanced, digital imaging workshops at the 8th Annual Meeting of the European Network of Forensic Science Institutes (ENFSI) Fingerprint Working Group in Split, Croatia. The ENFSI Fingerprint Working Group promotes the development and improvement of best practices and techniques in fingerprint detection (location and recovery), digital imaging, and comparison and identification.

Countries represented at this conference included Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Netherlands, Norway, Poland, Portugal, Romania, Russia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Turkey, Ukraine, and the United Kingdom. For the first time ever, attendees from South Africa also attended the ENFSI Conference. Each country represented at the ENFSI Conference was given a copy of Foray Technologies' Image Calibration Utility and the Grayscale Pattern Removal Filter.

Immediately after the ENFSI conference, Ski went to Berne, Switzerland, where he conducted three, one-day hands-on advanced digital imaging workshops for the Swiss Federal Department of Justice and Police (FDJP) Federal Office of Police (Fedpol). The classes in Switzerland were translated by Dr. Axel Glaeser, Head of the FDJP Fedpol AFIS DNA Services.

Ski said he had such a great time on this trip that he wasn't ready to come home when the training was done.
